AGREEMENT

ACCESS MUST MEET ALL REQUIREMENTS AS SET FORTH IN THE ROAD STANDARDS OF NAPLES CITY.

1. To construct driveway(s) in a safe manner so as to not interfere with or endanger public travel and to perform all work in a neat and workmanlike manner. To use materials acceptable to Naples Public Works and to leave the right-of-way clean and in a condition equal to or better than the original condition.
2. To fully protect the traffic on the street during construction by proper barricades, flagman, etc. to hold harmless the City of Naples, its employees from all expenses, claims or liability arising out of alleged damages of any nature to any person or property due to the construction performance or nonperformance of work, or existence of said driveway.
3. That no driveway(s) shall be constructed such that there will be parking or servicing of vehicles on the street right-of-way.
4. That the profile grade of the driveway(s) shall be constructed as indicated on the attached plan or sketch and shall in no case be graded or maintained such that the water drains onto the street.
5. That Naples City reserves the right to inspect these installations at the time of construction and at all times thereafter, and to require such changes, maintenance and repairs as may at any time be considered necessary to provide protection of life and property on or adjacent to the street.
6. That this permit becomes VOID if the construction is not completed within _____ days after approval date.

7. To any additional requirements as set forth under Naples Engineer requirements/comments or any on the sketch or plans.
